	3.	To ensure the health and safety of participating students dur- ing performances.		
	Parents shall be allowed to place voluntarily in the testing pool their children who are not participants in the extracurricular activities. These students shall take an initial test before entering the testing pool. Each student volunteered for the pool by his or her parents in this manner shall remain in the testing pool on a school-year basis, unless the parents submit a written statement to remove their child from the pool.

Consent	Before a student is eligible to participate in extracurricular activi- ties, the student shall be required annually to sign a consent form agreeing to be subject to the rules and procedures of the drug- testing program. If the student is under the age of 18, the student's parent or guardian shall also sign a consent form. If appropriate consent is not given, the student shall not be allowed to participate in extracurricular activities.
Use of Results	Drug test results shall be used only to determine eligibility for par- ticipation in extracurricular activities. Positive drug test results shall not be used to impose disciplinary sanctions or academic penal- ties.
	Nevertheless, nothing in this policy shall limit or affect the applica- tion of state law, local policy, or the Student Code of Conduct. A student who commits a disciplinary offense shall be subject to con- sequences in accordance with the Student Code of Conduct.
Behavior That Will Trigger Testing	A student enrolled in the testing program shall immediately be sin- gled out for testing upon being reported by law enforcement offi- cials through official notification, or other reliable means that would be sustainable upon appeal, to have been involved with alcohol or drug activity, i.e., selling, giving, delivering, using, possessing, or being under the influence of the drugs listed in this policy. A student enrolled in the testing program who is found to be involved in drug or alcohol activity, i.e., selling, giving, delivering, using, possessing, or being under the influence of the drugs listed in the policy, while on or within 300 feet of school property or while attending a school- sponsored or school-related activity on or off school property shall be dealt with as if the student has a positive test result for the sub- stances prohibited in this policy and shall also be subject to disci- plinary measures as outlined in the Student Code of Conduct, stu- dent handbook, or Board policy.
Confidentiality	Drug test results shall be confidential and shall be disclosed only to the student, the student's parents, and designated District officials who need the information in order to administer the drug-testing program. Drug test results shall not be maintained with a student's academic record. Results shall not be otherwise disclosed except as required by law.
Testing Laboratory	The Board shall contract with a certified drug-testing laboratory to conduct testing of students' urine samples.
	Testing laboratories shall not release statistics regarding the rate of positive drug tests to any person or organization without consent of the District.
